

**NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS

TO THE CALIFORNIA CODE OF REGULATIONS, TITLE 24
(CALIFORNIA BUILDING STANDARDS CODE)**

The California Building Standards Commission (CBSC), on behalf of the Office of the State Fire Marshal is providing notice of code changes intended for the 2016 California Building Standards Code, Part 2.5.

CBSC will accept written comments concerning the notice of proposed action for at least 15-days between November 17, 2015 and December 2, 2015. All written comments for this period must be submitted no later than **5:00 p.m. on December 2, 2015.**
