The DSA-AC proposes to adopt the 2010 edition of the CPC with existing un-amended regulations (other than revising structure, syntax, cross-reference, grammar, or punctuation) as follows:

- Amend and adopt as amended Plumbing regulations in Chapter 1, Division 1, Section 1.9 & 1.9.1 with Note
- Adopt and carry forward existing Plumbing regulations un-amended in Chapter 4
