The Division of the State Architect (DSA-AC) proposes to repeal all provisions in the 2007 edition of the California Mechanical Code (CMC):

DSA-AC proposes to:

- Repeal DSA 'X' in Matrix Adoption Table, which states: 'DSA-AC adopts only those sections that are listed below'
- Repeal DSA 'X' in Matrix Adoption Table, which indicates DSA-AC adoption of Section 109.1.
- Repeal DSA-AC Note under Section 109.1.
