ORDER DENYING REQUEST TO
VACATE DATES, GRANTING
CONTINUANCE, AND SETTING
PREHEARING CONFERENCE AND
DUE PROCESS HEARING

On June 14, 2011, the parties filed a request to vacate the prehearing conference and due process hearing dates in this matter on the ground that the parties had reached an agreement and required additional time to finalize the settlement. The parties requested a Trial Setting Conference (TSC).

A due process hearing must be conducted and a decision rendered within 45 days of receipt of the due process notice unless an extension is granted. (34 C.F.R. § 300.515(a); Ed. Code, §§ 56502, subd. (f), 56505, subd. (f)(3).) Speedy resolution of the due process hearing is mandated by law and continuance of the hearing may be granted only upon a showing of good cause. (Ed. Code, § 56505, subd. (f)(3).) In ruling upon a motion for continuance, OAH is guided by the provisions found within the Administrative Procedure Act and the California Rules of Court that concern motions to continue. (Cal. Code Regs., tit. 1, § 1020; Cal. Rules of Court, rule 3.1332 .) Generally, continuances of matters are disfavored. (Cal. Rules of Court, rule 3.1332(c).)

OAH has reviewed the request for good cause and the request to vacate prehearing conference and hearing dates and set a TSC is denied. OAH will only set a TSC, or a status conference, in limited circumstances, for example when the parties have an executed final settlement that requires board approval. However, the parties have established good cause to continue the hearing.

Accordingly, the prehearing conference is continued to June 29, 2011 at 1:30 PM. The hearing is continued to August 1 through 5, 2011.
