4. The parties mutually agree to this amendment as follows. All actions noted below are by this reference made a part of the Agreement and incorporated herein:


- A. Amend contract term for an additional six months. The effective date of this contract is November 1, 2009 and this amendment extends the term through April 30, 2012.
