

- * Month, Day, Year that awardee reached the 25-year service level
- * If ordering a watch indicate Black or Brown leather strap and length of the strap
- * If ordering the Bracelet/Charm indicate bracelet size. Note: the maximum bracelet size allowed is 7 1/2" (for 25 year award only)
