

Section IV, Item E "Phase-In and Phase-Out Services" of the existing contract states that "Prior to contract termination, successful bidder(s) must furnish phase-out services for up to 120 working days. Additionally, the successful bidder(s) must negotiate in good faith a plan with a successor to determine the nature and extent of phase-in, phase-out services required."
