ACTION PLANNED BY THE COMMISSION ON BUILDING STANDARDS:

Agenda Items 6a, 6b, and 6c – Emergency Building Standards Readoption: The Commission adopted and approved emergency building standards at its January 27, 2017 meeting. The emergency building standards added, amended and/or repealed building standards relative to Exterior Elevated Elements (EEE) in the 2016 edition of the California Building Code, Part 2 and the California Existing Building Code, Part 10 of Title 24, California Code of Regulations. Each state agency is requesting a second readoption of these emergency building standards for a 90-day period pursuant to [Government Code Section 11346.1\(h\)](#) so they may complete the certifying rulemaking to make the regulations permanent. Agenda Item 7 – Intervening Code Adoption Cycle: The Commission will take action on Agenda Item 7 to approve, disapprove, further study, or approve as amended any of the proposed code changes to the 2016 edition of the California Building Standards Code, Title 24, California Code of Regulations. Upon adoption, these building standards will be codified and published as a 2016 intervening code supplement, distributed by the publishers as blue supplement pages by January 1, 2018 and become effective July 1, 2018. The commission action will be guided by the nine point criteria established in [Health and Safety Code Section 18930](#). The Commission will consider the Division of the State Architects' proposed changes and its justifications, the Code Advisory Committee (CAC) recommendations, and comments submitted during the public comment periods. The public may comment on any challenges to the proposals or CAC recommendations submitted during the comment periods. No new issues or new information challenging the proposed code changes may be presented to the Commission in the adoption of the proposed regulations. 6) **Readoption of Emergency Building Standards (Government Code Section 11346.1)**

- a) **California Building Standards Commission (BSC EF 01/17) approved by the Commission at its January 27, 2017 meeting:** These previously approved emergency building standards added, amended and/or repealed building standards relative to exterior elevated elements in the 2016 California Building Code, Part 2 and California Existing Building Code, Part 10 of Title 24. BSC is requesting a second readoption of these emergency building standards for a 90-day period pursuant to Government Code Section 11346.1(h).
- b) **Department of Housing and Community Development (HCD EF 01/17) approved by the Commission at its January 27, 2017 meeting:** These previously approved emergency building standards added, amended and/or repealed building standards relative to exterior elevated elements in the 2016 California Building Code, Part 2 and California Existing Building Code, Part 10 of Title 24. HCD is requesting a second readoption of these emergency building standards for a 90-day period pursuant to Government Code Section 11346.1(h).
- c) **Division of the State Architect (DSA-SS/CC EF 01/17) approved by the Commission at its January 27, 2017 meeting:** These previously approved emergency building standards added, amended and/or repealed building standards relative to exterior elevated elements in the 2016 California Building Code, Part 2 and California Existing Building Code, Part 10 of Title 24. DSA is requesting a second readoption of these emergency building standards for a 90-day period pursuant to Government Code Section 11346.1(h).

7) **Division of the State Architect-Access Compliance (DSA-AC 01/16):** Proposed adoption of amendments to the 2016 California Building Code, Chapter 11B, Part 2, Title 24.

8) **Discussion item requested by Commissioner Santillan:** Discussion on the Commission's final approval of the motions on Items 9, 10, 11, 12, and 13 at its June 20, 2017 meeting to adopt amendments to the 2016 California Plumbing and Green Building Standards Codes (Parts 5 and 11, Title 24, California Code of Regulations) related to recycled water, which amendments were filed with the Secretary of State on June 23, 2017.
