ACTION PLANNED BY THE COMMISSION ON BUILDING STANDARDS:

These enhanced building standards reflect amendments vetted and approved by the International Code Council for inclusion in the 2018 edition of the International Building Code (IBC) and the International Existing Building Code (IEBC). The IBC and IEBC are used as the base model code for the California Building Code and the California Existing Building Code.
