

**NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR PROPOSED
BUILDING STANDARDS**

CALIFORNIA CODE OF REGULATIONS, TITLE 24
(CALIFORNIA BUILDING STANDARDS CODE)**

The California Building Standards Commission (CBSC), on its own behalf and that of the Department of Housing and Community Development, Division of the State Architect, and Office of Statewide Health Planning and Development, is providing notice of the changes made to proposed regulations, Table 6-4 and Section 604.1, which were the subject of an initial 45-Day public comment period that began on March 28, 2008 and ended on May 12, 2008, including a public hearing that was held on May 6, 2008, **and** a second 45-Day post-hearing public comment period that began on July 11, 2008 and ended on August 25, 2008. The changes to Table 6-4 and Section 604.1 are in response to comments received during the second 45-day public comment period and also due to changes to the Recirculated Draft Environmental Impact Report (RDEIR).

CBSC will accept written comments for at least 15-days between November 25, 2008 and December 9, 2008. All written comments must be submitted to the CBSC no later than 5:00 p.m. on December 9, 2008, and addressed to:
