

**NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect – Structural Safety, Office of Statewide Health Planning and Development, and the Department of Housing and Community Development is providing notice of code changes intended for the 2013 California Building Standards Code.
