

**NOTICE OF 45-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS**

**OF THE CALIFORNIA BUILDING STANDARDS COMMISSION, DEPARTMENT OF
HOUSING AND COMMUNITY DEVELOPMENT AND THE DIVISION OF THE
STATE ARCHITECT – ACCESS COMPLIANCE, TO CALIFORNIA CODE OF
REGULATIONS, TITLE 24
(CALIFORNIA BUILDING STANDARDS CODE)**

The California Building Standards Commission (CBSC), on its own behalf and that of the Department of Housing and Community Development, Division of the State Architect- Access Compliance is providing notice of code changes intended for the 2013 California Building Standards Code.

CBSC will accept written comments concerning the notices of proposed actions for at least 45-days between March 21, 2014 and May 5, 2014. All written comments for this period must be submitted no later than 5:00 p.m. on May 5, 2014.
