

**NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS**

**OF THE CALIFORNIA BUILDING STANDARDS COMMISSION (CBSC), THE
DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT (HCD) AND

The California Building Standards Commission, on its behalf and that of the Department of Housing and Community Development and the California Department of Public Health is providing notice of proposed code changes intended for the 2013 California Building Standards Code.
