Information provided on all forms will be verified by DSA, and any unverifiable information or incomplete forms will not count toward required qualifications.

- 1. PROJECT NAME.** Indicate the name of the project, such as the facility or building name. For applicants with experience in building code-enforcement inspection at a local jurisdiction, the Experience Record may list "various" in the Project Name field. Such an application must include a letter of employment verification from the local jurisdiction listing dates of employment, duties performed, and types of buildings inspected.
