INSTRUCTIONS

Overview

The Division of the State Architect (DSA) has statutory authority to propose to the California Building Standards Commission (CBSC) amendments to Chapter 11B of the California Building Code (CBC) addressing accessibility of the built environment. DSA created the ACC, a standing body comprised of representative stakeholders, to assist in this task. DSA is seeking individuals to participate as members of the ACC and is accepting applications on an ongoing basis.

ACC Role

The ACC has been established to work cooperatively with DSA to support DSA's rulemaking processes. All approved ACC members have agreed to work collaboratively with DSA and other ACC members to meet the goals of the ACC, whose purpose is to:

- 1. Offer input and feedback regarding proposed amendments to the CBC.
- 2. Help create transparency related to the discussion of proposed amendments and recommendations made by the ACC for the rulemaking record.
- 3. Offer code change proposals for consideration by DSA that address the diverse needs of code beneficiaries (people who need an accessible environment) and the clarity sought by code users (people who design, build, own, operate or regulate the built environments).
- 4. Identify opportunities to strengthen public awareness, engagement and training to support regulatory development and CBC compliance.

Stakeholder Representation

The ACC is made up of 13 individuals:

- Four Individuals with Disabilities
- Two Disability Advocates
- One Design Professional
- One Building/Construction Industry Representative
- Two Jurisdictional Enforcement Representatives
- Two Building Owner/Facility Management Representatives
- One Certified Access Specialist

and two ex-officio members:

- One Division of the State Architect (DSA) representative
- One Housing and Community Development (HCD) representative

Membership Expectation

The ACC is a consultative or advisory body, without formal decision-making authority. The ACC will offer both input and feedback on DSA's proposed amendments to the accessibility regulations, and offer suggestions for amendments to the accessibility regulations of the CBC for DSA's consideration.

The ACC is facilitated by an independent facilitator to keep meetings productive and collaborative. The ACC operates using a collaborative approach to decision making and strives first for unanimity but will use a consensus of the majority when necessary. Minority opinions are welcome and will be included in the record of the meetings.

ACC members may identify with one or more constituency group, and members are encouraged to take a wide view of issues discussed, considering the needs of all stakeholders. However, each individual selected will be

chosen to "represent" one of the stakeholder groups identified for inclusion on the ACC, ensuring that as a group, many points of view are considered. Single-interest advocacy is not the role of ACC members, however, thoughtful representation of the group they are chosen to represent is a member's responsibility. Finding ways to engage and conduct meaningful outreach to their constituency is expected of members.

More information on meeting frequency and member responsibility is addressed in the ACC Charter.

How to Apply

Each individual must submit a complete ACC Application. Incomplete applications will disqualify the individual being considered for service. Applicants must:

- 1. Complete all questions on the ACC Membership Application.
- 2. Submit the completed form by email to DSAACCApplications@dgs.ca.gov. Applicants have the option to submit a resume in addition to the application, but it is not required.

NOTICE ON COLLECTION

Effective Date: April 12, 2022

Collection of Personal Information. The California Department of General Services' (DGS), Division of the State Architect (DSA) administers the Access Code Collaborative (ACC) to ensure diverse public participation in the building and standards and regulations development process as specified in Government Code section 4450(b) and California Health and Safety Code section 18934. DSA collects Personal Information (as defined in the DGS Privacy Policy) such as: applicant's name, city, email address, phone number, relevant experience, and disability details.

Use of Personal Information. DSA collects Personal Information for the purpose of communicating with applicants and establishing applicant eligibility to serve on the Access Code Collaborative. This requires each applicant to:

- Provide their name, city, email address and phone number.
- Identify their relevant experience by selecting all of the following that apply:
 - Familiarity with state and or federal accessibility standards.
 - Past participation in a DSA access code development task force.
 - Past participation in access code development at public meetings or submissions of written comments.
- Identify the constituencies that they represent to ensure representation from a cross section of stakeholder groups. Applicants are to select all of the following that apply:
 - Person with Disability
 - Disability Advocate
 - Design Professional
 - Building Owner / Facility Management Representative
 - Certified Access Specialist (CASp)
 - Code Enforcement Representative
 - Building/Construction Industry Representative.

Providing the following information is mandatory: Applicant Contact Information, Member Relevant Experience, Stakeholder Representation, Preferences, and Statement of Interest. If you decline to provide this information, DSA will not be able to consider the applicant a candidate for the ACC.

Sharing of Personal Information. DSA will share your Personal Information and other data with representatives from the Department of Rehabilitation and the California Commission on Disability Access, who will be provided with copies of ACC Applications as part of the membership selection process. If selected for membership, a biography will be made available on the DSA Access Code Collaborative web page. Member biographies include information such as the stakeholder group(s) represented by each member and a summary of relevant personal and professional experience. Personal information may be shared with other state and/or local agencies who support or oversee the Program for the following reasons:

- Provide Program services.
- Program management, reporting and evaluation.
- Engage in ordinary business and emergency operations.
- Complying with law, protecting legal rights.
- Ensuring safety of the public, employees, and property.

Furthermore, any Personal Information collected is subject to the protections and limitations in the California Information Practices Act, the California Public Records Act, and state policy. DGS' general privacy policy is available at: https://www.dgs.ca.gov/Privacy.

Possible Disclosure of Personal Information. We may be required to disclose your information to comply with applicable laws (including laws outside of your country of residence), regulations, court orders, government, and law enforcement requests, including national security or other law enforcement requirements. Additionally, if we reasonably believe that it is necessary or appropriate, we reserve the right to use or disclose your information to allow us to pursue available claims or remedies and protect our legal rights, property or the safety of our employees, or others, to the extent allowed by applicable law.
