

**NOTICE OF 45-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS**

**OF THE DIVISION OF THE STATE ARCHITECT / ACCESS COMPLIANCE
(DSA/AC) TO THE CALIFORNIA CODE OF REGULATIONS, TITLE 24
(CALIFORNIA BUILDING STANDARDS CODE)**

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect – Access Compliance are providing notice of code changes intended for the 2016 California Building Standards Code.

CBSC will accept written comments concerning the notice of proposed action for at least 45-days between October 8, 2015 and November 23, 2015. All written comments for this period must be submitted no later than 5:00 p.m. on November 23, 2015.
