The Interagency Agreement (IA) between the California Department of Education (CDE) and the Office of Administrative Hearings (OAH) requires OAH to report on a quarterly basis certain information related to mediations and due process and expedited hearings, as well as information required to be maintained according to state and federal law.<sup>1</sup> The following report addresses those IA reporting requirements.

### CASE FILINGS<sup>2</sup>

During the fourth quarter of fiscal year 2011-2012, OAH received 963 new case filings.<sup>3</sup> For a comprehensive chart of the number of filings since 2005, please see Attachment A at page 21.

### CASES BY FILING PARTY

Overall, there were 963 total cases filed this quarter, which consisted of 829 student-filed cases and 134 district-filed cases.<sup>4</sup> Of the student-filed cases, 10 cases involved both expedited and non-expedited issues (dual hearings), with four cases that were exclusively expedited issues.<sup>5</sup> Of the district-filed cases, there were no cases that involved expedited issues or dual hearings.<sup>6</sup> Of the 963 cases filed, eight requests by students and no requests by districts were for a due process hearing only. A detailed list of all student-filed cases this quarter broken down by district appears in Attachment B beginning on page 22.

Of the 963 cases opened by OAH this quarter, 955 requests were for mediation related to due process hearing or mediation-only this quarter.<sup>7</sup> Of the 955 requests for mediation, 65 were requests for mediation-only.<sup>8</sup> The remaining 890 requests for mediation were related to due process hearing requests.<sup>9</sup> Of the total requests for mediation, 10 student-filed cases and no district-filed cases were dual hearings.<sup>10</sup>



### LEGAL REPRESENTATION

During the fourth quarter, 963 cases were filed, which consisted of 829 student-filed requests and 134 district-filed requests. Of the 829 cases filed by students requesting due process, 604 cases (73 percent) were filed by attorneys; of the 134 district-filed cases, 104 cases (78 percent) were filed by attorneys.<sup>11</sup> Of the 963 cases filed this quarter, 708 cases (74 percent) were filed by attorneys. This fiscal year, 77 percent of student cases and 78 percent of district cases were filed with legal representation.



### GRADE LEVEL

The majority of the 963 cases filed this quarter originated from students in the primary grades (489 cases), followed by those in high school (197 cases), junior high school (150 cases) and preschool (113 cases). The grade level of the student was not specified in 14 of the case filings.<sup>12</sup>


### ISSUES AND REMEDIES

Cases filed this quarter involved a variety of issues and requested remedies. The number of issues raised varied per case, with some cases raising only one issue, and others raising several issues. The most common issues raised in the 963 cases filed this quarter were placement (493 cases) and assessment (414 cases). Other issues included: designated instruction and services (363 cases), speech and language services (313 cases), one-to-one aide services (200 cases), occupational therapy services (185 cases), goals and objectives (125 cases), eligibility (107 cases), extended school year services (85 cases), private services (67 cases), procedural violations (65 cases), mental health services (49 cases), and discipline (four cases). Compensatory education was requested as a remedy in 335 cases and reimbursement was requested as a remedy in 299 cases.<sup>13</sup>


### ELIGIBILITY CATEGORY <sup>14</sup>

The majority of cases filed this quarter involved students identified under the eligibility category of Autistic-Like Behaviors (308 cases). Other identified areas of eligibility included: Specific Learning Disability (137 cases), Other Health Impaired (133 cases), Speech or Language Impairment (123 cases), Emotional Disturbance (67 cases), Intellectual Disability (39 cases), Orthopedic Impairment (17 cases), Hearing Impairment (12 cases), Deafness (seven cases), Visual Impairment (four cases), and Traumatic Brain Injury (three cases). The student's area of eligibility was not identified in 263 cases.<sup>15</sup>




### CLOSED CASES

During this quarter, 881 cases were closed. Currently, 754 cases remain pending.<sup>16</sup> Of the 754 cases pending, 721 are related to due process hearing requests and 33 are related to mediation-only requests. Of the 881 cases closed, 822 were related to due process hearing requests and 59 were related to mediation-only requests. Of the 881 cases closed, 858 (97 percent) were resolved in some manner without need for a due process hearing.<sup>17</sup> For the fiscal year to date, 96 percent of cases have resolved without need for a due process hearing.




The majority of cases closed this quarter were resolved outside the mediation or resolution session process (353 cases), followed by those that settled during mediation (305 cases), and those cases withdrawn by the filing party without explanation (143 cases). Additionally this quarter, 19 cases resolved during the resolution session<sup>18</sup>, 12 mediation-only cases were not settled at mediation, nine cases were dismissed after failing to amend following a notice of insufficiency, six cases were dismissed by a motion to dismiss, six cases were dismissed due to inactivity, and five cases were closed for other reasons. Out of the 881 cases closed this quarter, 23 were closed following a hearing and decision on the merits.




## MEDIATIONS

This quarter, 444 mediations were held. The mediations were held in cases opened this quarter and in cases that were pending from prior quarters. Of the 444 mediations held this quarter, in 14 cases an additional mediation session was scheduled. Of the 444 mediations held, 405 were related to due process hearing requests, two cases involved expedited issues, five cases were related to dual hearing requests and 39 were related to mediation-only requests.

For mediation requests related to due process hearing, 261 cases reached an agreement at mediation,<sup>19</sup> and 27 mediation-only cases reached an agreement,<sup>20</sup> for a total of 288 cases resulting in an agreement.<sup>21</sup> In the two cases involving expedited issues that went to mediation, neither case reached an agreement. In the five dual cases, which involve both expedited and non-expedited issues that went to mediation, three reached an agreement.<sup>22</sup>

Out of the 444 mediations held this quarter, mediation was successful in 288<sup>23</sup> cases (65 percent), with 156 mediations resulting in impasse. At the end of this quarter, 457 cases have mediations pending<sup>24</sup> and 721 cases have hearings pending.<sup>25</sup>




For the 2011-2012 fiscal year, OAH has conducted 1,804 mediations, with 1,139 resulting in an agreement and 665 resulting in impasse. The overall mediation success rate for fiscal year 2011-2012 is 63 percent. For the 2011-2012 fiscal year, 96 percent of cases have resolved without need for a due process hearing decision.



### DUE PROCESS HEARINGS

During the fourth quarter, out of the 881 cases closed, 25<sup>26</sup> final decisions were issued. Of the 25 decisions issued, no decisions were issued within the 45-day timeline, 21 were issued within the 45-day timeline plus extension, and one decision was issued late.<sup>27</sup> Three decisions were timely issued in a case with expedited issues and no changes of placement were ordered for this quarter.<sup>28</sup> Overall, this quarter, 99 percent of decisions were issued within the requisite timeline. For the 2011-2012 fiscal year, OAH has issued 114 decisions and 99 percent have been issued within the requisite timelines.

Based upon the issues for hearing identified by the parties, students prevailed on all issues in four hearings (16 percent) and districts prevailed on all issues in 14 hearings (56 percent). In seven of the 25 decisions issued (28 percent), the issues in the decision were split between student and district, with students prevailing on 13 issues and districts prevailing on 28 issues.<sup>29</sup>



For the current fiscal year, students have prevailed on all issues in 18 hearings (16 percent), districts have prevailed on all issues in 68 hearings (60 percent), and 28 cases (24 percent) resulted in a split decision of the issues. Copies of all decisions have been provided to CDE and have been posted on the OAH website.

Of the 25 decisions issued this quarter, one case involved preschool students, 13 cases involved elementary school students, five cases involved middle school students, and six cases involved high school students.

On average, the due process hearings lasted five days, with students using 53 percent of the hearing time to present their cases and districts using 46 percent of hearing time for case presentation.<sup>30</sup> During case presentation, students called an average of six witnesses per case and the districts called an average of five witnesses per case.<sup>31</sup>

The hearings involved multiple areas of disability. The cases involved students identified with a disability area of Autistic-Like Behaviors (13 cases), Other Health Impaired (three cases), Speech or Language Impairment (two cases), Deafness, (one case), Emotional Disturbance (one case), Hearing Impaired (one case), Intellectual Disability (one case), Orthopedic Impaired (one case), Specific Learning Disability (one case), and Traumatic Brain Injury (one case).

### **RESOLUTION SESSIONS**

The IDEA requires school districts to hold resolution sessions within 15 days of receipt of a student’s complaint. While there is no legal requirement to report this data to OAH, CDE requests that OAH track this information. Accordingly, OAH sends letters to school districts requesting them to report for each case if a resolution session was held, the outcome of each session, and other information about each session. This quarter, based on the information OAH received, 149 resolution sessions were reported as held and 341 were reported as not held. Of the 149 resolution sessions reported as held, there was one session regarding an expedited case and two sessions regarding cases involving both expedited and non-expedited issues.<sup>32</sup> Attachment C, beginning on page 42, reports all resolution session information reported to OAH and Attachment D beginning on page 63 details the matters from the fourth quarter that OAH has not received any resolution session data.

## MOTIONS

Prehearing motions and Notices of Insufficiency (NOIs) comprise a substantial amount of the work completed by administrative law judges. For this quarter, 318 prehearing motions and 30 NOIs were filed by the parties and ruled upon by OAH. Of the 318 prehearing motions that were ruled on by OAH, 52 were filed by students, 55 were filed by districts or other local education agencies and 211 motions were stipulated.<sup>33</sup> Of the 30 NOIs filed, 17 were found sufficient, 10 of the complaints were found insufficient, and three were found partially sufficient. Nine cases were dismissed for insufficiency after failing to amend the complaint.<sup>34</sup>


There were 318 prehearing motions filed this quarter. Of the 52 motions filed by students, 35 were granted, two were granted in part, 13 were denied, and two were deemed moot. Of the 55 motions filed by districts or other local education agencies, 33 were granted, 18 were denied, and four were granted in part. Of the 211 stipulated motions, 205 were granted, five were denied, and one was deemed moot.<sup>35</sup> The prehearing motions involved a variety of issues, with the largest number involving motions to continue (240 motions).

**NON-ENGLISH-SPEAKING STUDENTS AND INTERPRETERS**

During this quarter, 155 non-English-speaking students were identified through the due process hearing request forms.<sup>36</sup> Of the 155 non-English-speaking students, 141 students spoke Spanish, nine students spoke Vietnamese, two students spoke Farsi, one student spoke Korean, one student spoke Russian, and one student spoke Serbian. OAH received 136 requests for the assistance of an interpreter at a hearing or mediation<sup>37</sup>.

**STUDENTS OF COLOR**

CDE has requested that OAH collect data on the number of students of color accessing the system. To facilitate this request, OAH’s due process hearing request form asks the parties to voluntarily provide this information. However, not all hearing requests are made using the OAH form. This quarter, 15 students reported as being a student of color and nine students reported as not being a student of color.<sup>38</sup> The remaining students did not state whether they were a student of color.



### TRANSCRIPT REQUESTS AND APPEALS

Data on the number of appeals to state and federal courts and appellate outcomes are collected on an ongoing basis and include all cases that OAH was notified were appealed since July 2005. This quarter, OAH received 24 requests for transcripts, and was notified of four new appeals filed. Of the appeals reported in previous quarters, two OAH decisions were upheld and two appeals resulted in settlement.<sup>39</sup>

OAH has updated the appeals tracking process in order to provide the most accurate information. Based on correspondence with the parties and filings that have been provided to OAH, 171 cases have been appealed since July 2005. Of the 171 cases that have been appealed, 49 have settled, 43 have been dismissed, 41 were upheld, seven were remanded, four were reversed, and six were withdrawn. There are 21 cases that are currently on appeal.



A detailed list of cases on appeal and their outcomes after appeal is included in Attachment E beginning at page 71. OAH is also now tracking appeals that have been further appealed to a higher court, the details of which can be found in Attachment F at page 78. Due to the difficulty in identifying which cases are appealed and the appellate outcomes, parties are invited to notify OAH of any case on appeal or any outcome on appeal that is not included in Attachment E or Attachment F.

**MEDIATION AND HEARING EVALUATIONS**

OAH is required to send evaluations to all parties attending mediations and hearings. The evaluations contain a rating scale of 1 to 5, with 1 being poor/very dissatisfied and 5 being excellent/extremely satisfied. The evaluations ask the parties to evaluate the mediation, the administrative law judge and OAH in general.

This quarter, 123 mediation evaluations were returned to OAH. Evaluations were completed by parents (26 cases), legal counsel for parents (eight cases), advocates for parents (four cases), school district representatives (57 cases), and legal counsel for districts (12 cases). In 16 cases, the evaluator did not indicate his or her role in the mediation.
