ORDER GRANTING MOTION TO
AMEND COMPLAINT

On January 11, 2010, Student filed a Due Process Hearing Request (complaint), naming District. On September 20, 2010, the parties filed a joint stipulation to permit Student to file an amended Due Process Hearing Request (amended complaint).

An amended complaint may be filed when either (a) the other party consents in writing and is given the opportunity to resolve the complaint through a resolution session, or (b) the hearing officer grants permission, provided the hearing officer may grant such permission at any time more than five (5) days prior to the due process hearing. (20 U.S.C. §1415(c)(2)(E)(i)(II).)¹ The filing of an amended complaint restarts the applicable timelines for the due process hearing. (§1415(f)(1)(B).)

The motion to amend is timely and is granted. The amended complaint shall be deemed filed on the date of this order. The prehearing conference and hearing dates shall be reset as of the date of this order. The mediation date of September 23, 2010 will remain on calendar. OAH will issue a scheduling order with the new prehearing and hearing dates.
