MEDIATION AND HEARING EVALUATIONS

OAH is required to send evaluations to all parties attending mediations and hearings under Section G.7 of the IA. The evaluations contain a rating scale of 1 to 5, with 1 being poor/very dissatisfied and 5 being excellent/extremely satisfied. The evaluations ask the parties to evaluate the mediation or hearing, the administrative law judge and OAH in general.

This quarter, 151 mediation evaluations were completed. Evaluations were completed by parents (22 evaluations), legal counsel for parents (17 evaluations), advocates for parents (four evaluations), school district representatives (92 evaluations), and legal counsel for districts (16 evaluations). The role of the evaluator was indicated on all completed evaluations.
