DEFERRED MAINTENANCE PROGRAM  
MAXIMUM BASIC GRANT DEPOSIT

PURPOSE OF REPORT

To report those districts that did not deposit the calculated maximum basic grant amount into the Deferred Maintenance (DM) Fund.

DESCRIPTION

As a condition of receiving the 2006/2007 basic grant apportionment approved at the December 2007 State Allocation Board meeting, districts are required to match these funds with a deposit into its DM Fund and have its County Office of Education certify the deposit. Current law requires those districts to report to the Legislature whenever it does not make their maximum basic grant deposit.

The districts listed on the Attachment have not submitted a certified maximum 100 percent deposit meeting the requirements in law.

AUTHORITY

Pursuant to Education Code Section 17584.1(b) districts that do not deposit the maximum basic grant apportionment amount calculated by the California Department of Education shall submit a report to the Legislature and the SAB. In addition, the law requires that these districts' reports detail the reasons why funds were not transferred.

RECOMMENDATION

Accept this report.
