ANNUAL ADJUSTMENT TO SCHOOL FACILITY PROGRAM GRANTS

PURPOSE OF REPORT

To report the annual adjustment in the School Facility Program (SFP) Grants as provided in the Education Code and Title 2 of the California Code of Regulations.

DESCRIPTION

The SFP Regulations require that various grant amounts of the SFP shall be adjusted annually based on the change in the Class B Construction Cost Index each January. The specific regulation sections are noted on the Attachment. The consent items on this agenda requesting SFP funding reflect the updated adjustments for January 2004.

The Class B Construction Index as of January 1, 2004 is 1.51, which resulted in a 3.42 percent increase in the index. The figures shown on the Attachment reflect the calculated increase.

RECOMMENDATION

Approve the increase to the grant amounts as shown on the attachment for the use of SFP applications approved on or after January 1, 2004.

BOARD ACTION

In considering this item, the Board approved the Staff's recommendation, with the following direction:

- The Board directed Staff to conduct a study, working with the Department of Finance, to determine if the increase to the construction index for school construction is appropriate for purposes of the annual adjustment in 2005.
