**RE: Supplement 1: Amendments #1 and #2 and amended User Instructions –  
Non-Mandatory Statewide Agreement # 01-14-65-57 for Specialty and  
Infusion Pharmacy**

This Broadcast Bulletin announces the posting of Amendments #1 and #2 to the Agreement with Walgreens Specialty Pharmacy, LLC, Crescent Healthcare, Inc., Option Care Enterprises, Inc., River City Pharmacy, Inc., and Walgreens Home Care, Inc., effective October 16, 2014 through October 15, 2017. Included are the following changes:

- Amendment #1: Exhibit H, Assignment, is added to Agreement. This effectively adds four Walgreens affiliated companies and assigns all responsibilities for the Agreement to “Walgreens Specialty Pharmacy LLC., Crescent Healthcare Inc., Option Care Enterprises, Inc., River City Pharmacy, Inc., and Walgreens Home Care, Inc.”
- Amendment #2:
  - Exhibit A, Statement of Work, is amended to reflect the new company name
  - Exhibit A-1, Technical Requirements, is amended as outlined in table found in document named Amendment 2.
  - Exhibit A-2, Administrative Requirements, is edited to reflect new Payee Data Records for new companies.
- The following areas of User Instructions are amended:
  - Item 4, Contract Administration.
  - Item 18, payment, now contains Payee Data Record and Seller’s Permit numbers for Walgreens Specialty Pharmacy LLC., Crescent Healthcare, Inc., Option Care Enterprises, Inc., River City Pharmacy, Inc., and Walgreens Home Care, Inc.
  - Attachment A, Referral Intake Process, is amended to include Payee Data Records for Crescent Healthcare, Inc., Option Care Enterprises, Inc., River City Pharmacy, Inc., and Walgreens Home Care, Inc.
  - Exhibit G-2, Services Pricing, has been updated to include HCPCS numbers.
