1. **SCOPE:** This Participating Addendum covers Small Package Delivery Services for State Agencies and political subdivisions/local governments. A political subdivision/local government is defined as any city, county, city and county, district, or other local governmental body or corporation, including the California State Universities (CSU) and University of California (UC) systems, K-12 schools and community colleges empowered to expend public funds. Each political subdivision/local government should make its own determination whether the WSCA program is consistent with its procurement policies and regulations.
2. **CHANGES:** Changes to the Participating Addendum including Amendment #1 and the terms and conditions of the signed Master Service Agreement are as follows:

- a. Exercising option to extend contract for one (1) year with three (3) additional year options.

Change contract period:

From: November 1, 2006 through August 27, 2007

To: August 28, 2007 through August 27, 2008

- b. Update Accessorial Rates per Amendment One of the State of Utah Cooperative Contract.

All other terms and conditions shall remain the same.
