The contract is amended to:

- Include a one point eight percent (1.8%) increase on, non MBG and MBG rates. All rate charts are attached and amended hereto.
 - o The rate increase is based on the June 2012 CPI-U Index for Transportation (yr. over yr. unadjusted percent change) as reported July 17, 2012.
- An updated Accessorial page to reflect 2012 incented accessorials and the Fees and Other Charges as listed in the 2012 UPS Rate & Service Guide which will be frozen through 8/27/2013.
- Include a Single Carrier Rate Option – This rate option will apply to Participating State/Entities who elect to use UPS as their single carrier under the WSCA Agreement.
 - o This rate option is one point eight (1.8%) less than the Multi Carrier Non MBG rates
 - o This rate option will include the ability to file for Money Back Guarantees (as specified in the UPS Rate & Service Guide and Tariff in effect at time of shipping)
 - o UPS reserves the right to modify pricing from the Single Carrier Rate to the UPS Multiple Carrier Rate if it is determined that the State/Entity signed multiple interstate Participating Addenda under WSCA.
 - o UPS further agrees to comply with the rate increase language as specified for this Single Carrier Rate Option
